The President and the Board of Trustees of the Village of Riverton held their regular board meeting on June 15, 2020 at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:01 pm. Those answering roll call: Trustees: Dave Charles, Ginger Payne, Joe Bartley, Jim Mileham, and Michelle Landess. Mayor Tom Rader and Trustee Russ Patrick were absent.

Trustee Mileham made a motion to approve June 1st regular board meeting minutes and pay the bills. It was seconded by Trustee Payne. Trustees Charles, Payne, Bartley, and Mileham voted yes. Trustee Landess abstained.
