

## Minutes

### Riverton Village Board

The President and the Board of Trustees of the Village of Riverton held their regular board meeting on August 2, 2021 at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:00 pm. Those answering roll call: Trustees: Russ Patrick, Dave Charles, Gina Rusciollelli, Joe Bartley, Jim Mileham, and Michelle Landess. Mayor Tom Rader was not in attendance.

The Pledge of Allegiance was recited.

Trustee Mileham made a motion to approve July 19<sup>th</sup> board meeting minutes and pay the bills. It was seconded by Trustee Landess. Trustees Patrick, Charles, Rusciollelli, Mileham, and Landess voted yes. Trustee Bartley voted present.

#### People to Address the Board:

Jim Cribbett addressed the board on behalf of the Library Board. He inquired about the status of the ADA accessible doors. Trustee Patrick replied that they are working on getting a contractor.

Mike Ray addressed the board on behalf of the Knights of Columbus. He gave an update on their Fall Festival scheduled for August 28<sup>th</sup> from 4:30 – 9 pm at the Field of Dreams. They will have food vendors, and a DJ. Superintendent Lyons suggested that the food vendors arrive on Friday so set up can be done while the village employees are there to assist.

Dave Rusciollelli addressed the board requesting city water be extended down Williamsville blacktop to his neighbors and himself. It would be approximately 2500 feet of water line. The board asked him to get an idea of how many people would be interested and they would discuss it further.

Trustee Bartley, chairperson of the Economic Development Committee, reported that the truck stop is continuing to move forward.
