Riverton Village Board

The President and the Board of Trustees of the Village of Riverton held their regular board meeting on August 15, 2022 at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:02 pm. Those answering roll call: Trustees: Dave Charles, Gina Rusciollelli, Joe Bartley, Jim Mileham, Michelle Landess, and Mayor Tom Rader. Trustee Russ Patrick was not in attendance.
